

Contribution rules of the association Emil5 e.V.

(in the following called association)

§ 1 Principle

These contribution rules are not part of the statutes. They regulate the contribution obligations of the members as well as the fees and apportionments. It can only be changed by the general meeting of the association.

§ 2 Resolutions

- (1) The General Meeting shall decide on the amount of the fees.
- (2) The contribution regulations are valid from 2 months after the resolution by the general meeting. By resolution of the general meeting, another later date can also be determined.

§ 3 Annual contributions and payment modalities

- (1) Forms of contribution per year:
 - a.) Full contribution - min. 24 €
 - b.) Reduced contribution (the reduction is based on self-assessment) - min. 12 €
 - c.) sustaining members - min. 120,00 €
- (2) The contributions mentioned in § 3 (1) a.) to c.) are to be understood as minimum contributions. They can be increased independently by the members or their authorized representatives.
- (3) Upon application, the membership fee may be waived by the Executive Board. A written application is required for this purpose.
- (4) The membership fee shall be valid for the respective year and may be adjusted for the following year by the member upon notification of the Executive Board with a notice period of 30 days until the end of the year.
- (5) The contributions must be transferred to the account of Emil5 e.V. by June 30 of the current year at the latest. In justified individual cases, an alternative method of payment (e.g. cash payment) may be requested from the Board.
- (6) Overpaid membership fees will not be refunded after leaving the association.

§ 4 Default of payment

- (1) The member has to take care of a punctual payment of the membership fee. If the membership fee has not been received by the association at the time specified in §3 (5), the member is in default of payment.
- (2) The association reminds not in time paid contributions. For this purpose, the Association may charge the member, starting with the second reminder, costs in the amount of 10 € per reminder.
- (3) The Executive Board is authorized to defer, reduce or waive contributions upon request. A legal claim to payment by installments, reduction and/or deferral of the dues debt does not exist.

(4) Should the payment obligation still not be fulfilled at the turn of the year (31.12.) after two reminders by the Executive Board, the Executive Board may exclude the member from the Association.

§ 5 Storage of personal data and data protection

The collection of contributions, fees and levies is carried out by means of data processing (EDP). The personal data of the members are stored in accordance with the Federal Data Protection Act.

§ 6 Association account

The membership fee is to be transferred to the association account. These are the bank details of the association account.
