The Data Protection Regulation (DS-GVO) provides that we must inform you at the time of collection of the data about the nature and extent of processing and about your rights. 1. responsible under data protection law

2. Legal basis and purpose of collection and processing

We collect and process your personal data according to Art.6 para.1 (b) DS-GVO for a specific purpose, because this is necessary for the organization and implementation of the membership relationship according to our statutes. You have recognized our statutes with your accession. In this context, everything that is necessary for the fulfillment of the purpose of the association and the tasks associated with it is earmarked. This includes in particular: The storage of data in the membership list, the processing for sending invitations to general meetings, for the collection of membership fees and, if necessary, notifications to the Studierendenwerk Thüringen.

In addition, we collect and process personal data because we as an association have a legitimate interest in doing so (Art. 6 para.1 (e) DS-GVO). Such a legitimate interest consists, for example, in informing the public by reporting on the activities of the association. 4. Internal recipients of the personal data

During the processing, the data will be disclosed to the members of the Association entrusted with the organization, to the extent necessary for the fulfillment of the purpose.

5. External recipients of personal data

Personal data will also be passed on to third parties for processing, depending on requirements and if necessary for the purpose of the association and its work.

6. Duration of storage / deletion

The personal data will be stored for the duration of the membership. They will be deleted as soon as they are no longer required for the purpose of processing, unless legal retention periods determine otherwise. In the period between termination of membership and deletion, we restrict the processing of your personal data, e.g. by removing your address from the email distribution list and restricting access authorizations.

7. Your rights

You have the following rights:

- the right to data portability according to Article 20 DSGVO,
- the right to lodge a complaint with a supervisory authority pursuant to Article 77 of the GDPR
- the right to revoke consent given at any time without affecting the lawfulness of the processing carried out on the basis of the consent until revocation.

Insofar as we base the processing of personal data on a balance of interests (for association purposes), you may object to the processing pursuant to Art. 21 DS-GVO. The objection must be met in whole or in part if there are valid reasons that oppose further processing. Please inform us of these reasons with the objection. We will then review the situation and either discontinue or adjust the processing or inform you of the weighty reasons for continuing the processing.
